4. FIRST AID MEASURES

Wash off with soap and plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Call a physician.

If swallowed:

Never give anything by mouth to an unconscious person. Rinse mouth with water. Consult a physician.

Use carbon dioxide, dry chemical powder, alcohol-resistant or polymer foam.

Special protective equipment for firefighters:

Wear self-contained breathing apparatus for firefighting if necessary.
